## VIII. ASSOCIATION REPORTS

### 1. Redlands Teachers Association/CTA/NEA

#### Stephen Caperton

- Shared that the Spring Fling Festival, a joint RTA and RESPA event, was recently held and provided a welcome opportunity for members to connect and enjoy time together.
- Declined to address policies on the agenda due to ongoing negotiations.

- Expressed concern over the quick return of previously tabled policies.
- Stated that school boards are not the place to resolve broader societal conflicts, and doing so diverts resources from student-focused needs.
- Emphasized the need for class size reduction in grades 1–3, noting current averages of nearly 30:1 compared to the target of 24:1.
- Highlighted the need for increased mental health support, with only one licensed clinical social worker serving the district.
- Noted that many teachers are still buying basic classroom supplies out of pocket.
- Called for additional paraprofessionals to support classroom instruction.
- Urged continued support for extracurricular programs like speech and debate and mock trial, as these are essential for student belonging.
- Raised concern about the tone of recent board meetings, stating that students are witnessing and mimicking divisive behavior on campus.
- Advocated for respectful discourse that acknowledges the humanity of all participants.

## 2. Redlands Education Support Professionals Association/CTA/NEA

Liz Huerta-Brewster

- Shared that the final site rep meeting of the year will be held in May and will honor six RESPA scholarship recipients.
- Announced the annual RESPA retiree dinner is scheduled for May 17 at the American Legion.
- Expressed gratitude for being honored at State Council on April 4 as the Paula Monroe CTA ESP of the Year.
- Reported that the RESPA FACE team collected over 500 hygiene items to support local families.
- Thanked the community for donations, noting that collective efforts strengthen support for all students and families.
- Stated enthusiasm for continuing collaboration with the FACE department on future events.
- Reflected on nearly two years of service as RESPA president and expressed appreciation for being re-elected.
- Addressed an unresolved issue regarding paraprofessional compensation from the 2022–23 school year.
- Explained that an MOU was signed moving paraprofessionals from range 15 to range 17, but it was not board-approved and later expired.
- Shared that although assurances were made to resolve the matter, no action has been taken to date.
- Noted that raises have been given to director-level staff and new positions created, while paraprofessionals remain undercompensated.
- Urged the board to revisit the issue and take corrective action to ensure fair compensation for paraprofessionals, whose work is vital to student success.

## IX. BOARD COMMITTEE REPORTS

Patty Holohan –

- CRY-ROP had a successful WASC pre-visit on March 14, with ambassadors effectively guiding visitors through pathways.
- REV aviation teacher attended an aviation conference and secured 18 desktops and a full cockpit flight simulator for the aviation program, marking a significant achievement.
- Invited board members to attend the Evening of Excellence and Student Showcase at San Bernardino Valley College on May 14.

Candy Olson –

- Evening of Appreciation for elementary schools on Wednesday, May 7 at 6:30 PM at the REV Blackstone Theater.
- Reminded everyone about the Harlem Wizards event on Friday, April 25.
- Encouraged attendance to support teachers and raise funds for classroom supplies.
- Noted the event promises entertainment as the Wizards face off against district staff.

Jeannette Wilson –

- The final steering committee meeting for the school year was held. Students will receive awards and recognition this Thursday night.
- Citrus Valley High School (CVS) and likely REV will have Compact Clubs next year. The clubs promote professionalism across social, academic, educational, and college readiness skills. Highlighted that students work hard to earn their awards, reflecting their commitment.

Michele Rendler –

- Attended the Parks and Rec Advisory Commission meeting where a tree dedication was approved for Herbert Israel Beale at Israel Beale Park.
- Met Angela Wilkinson, great-great-granddaughter of Israel Beale, and learned about family history including Charles Beale, the first African American football player and graduate of Redlands High School (1905), and former postmaster at Brookside Station.

1. Equity in Action Update – NaChé Thompson, Coordinator, Diversity & Equity

## Purpose:

Update on efforts to improve equity, safety, belonging, and student success in RUSD.

## Key Areas of Focus:

- Professional development for staff
- Support for families and students
- Collaboration across departments
- Addressing disparities in achievement and discipline

## Data Highlights:

- Ongoing achievement gaps in Math and ELA
- 65 racial slur incidents tracked across grade levels
- Disparities in suspension rates

## Initiatives:

- Site Equity Teams (136 participants across 3 cohorts)
- No Hate Zone training and classroom lessons
- Equity & Inclusion Task Force collaboration
- Hate speech response plan launched district-wide

## Next Steps:

- Expand No Hate Zone lessons
- Standardize responses to hate speech
- Increase family engagement and staff training
- Continue growing Equity initiatives across sites

2. Mental Health Screener Proposals in RUSD High Schools – Beatrix Williams, Love Afolbai, Brileigh Guillen, and Nahiara Modrow

- Youth mental health issues are rising nationally and locally; depression rates have increased 150% from 2011–2021.
- 50% of mental health disorders start by age 14; 75% by age 25, making school a key intervention point.
- Students with depression are twice as likely to drop out.
- Schools offer daily opportunity and access to trusted adults and resources.
- Current mental health support is reactive, based on visible signs (e.g., absenteeism, drop in grades, behavior, self-harm).
- Example: "Maya" is a high-achieving student with invisible mental health struggles; a screener would have helped her get support.
- Student leaders from mental health clubs hear peer concerns regularly and see gaps in support systems.
- Despite good intentions, staffing and systemic challenges lead to students falling through the cracks.
- Proposal: Implement a digital mental health screener in high school English classes, starting once a year and expanding to twice annually.
- A screener is a confidential questionnaire to identify students needing support early and proactively.
- Options for screeners include free tools like Google Forms or Kelvin; creating a new one may cost ~\$50,000 (could be funded via LCAP).
- Student survey responses showed many feel support is unclear or insufficient; most agree a screener would help.
- Real examples shared of students receiving help only after visible signs, raising concern for those suffering silently.
- The project began in November 2023 and has been developed with faculty and board collaboration since.
- Emphasis: this is a proactive solution created by students based on lived experience.

- Mental health directly affects academic success; this screener helps support all students, not just those in visible crisis.

Pat Molnar –

- Spoke about Pride flag representation/belonging.

Jenann Elias-

- Thanked all school librarians during National Library Month, for dedication, creativity and support for students.

Dr. Christopher Cain –

- Recommended to the Board to send a survey to community to receive their input.

Kevin O'Connor –

- Thanked the Board for sifting through all the things and do things for all not just a minority.

Eriko Grossman –

- Criticized RUSD for failing to protect students.

Aya Francisco –

- Expressed a wish for a world where people come together and all stand on equal footing without oppression.

Greg Brittain –

- Expressed concerns about declining academic standards in public education, citing national proficiency data and urging the board to prioritize academic excellence over political or cultural influences.

John Berry –

- Complemented the Board for running the board effectively to allow public to express their First Amendment words.

Addison Lohman –

- Spoke in support of maintaining inclusive reminders in classrooms, emphasizing that such symbols help all students feel valued and welcomed.

Paula Brannon –

- April is Autism Awareness Month

Siw Heede–

- Read message on behalf of son. Ban policies prey on vulnerable marginalized groups there is. They tell the group that they are not wanted they don't belong and they don't deserve to be safe.

Kelsie McGee –

- Spoke in opposition to proposed policies requiring disclosure of students' gender identities and banning identity-based symbols and literature, emphasizing the importance of trust, inclusion, and authentic education.

Gina Porter –

- Clarified library book selection and removal policies, emphasized that no pornography is present, warned against censorship and book bans, and highlighted the importance of equitable access and parental choice without infringing on others' rights.

Paige Mann –

- Expressed concern that the proposed revision to AR 1312.2 allows books to be removed from libraries too easily, bypassing professional guidelines and enabling repeated complaints to indefinitely block student access.

Valerie Taber –

- condemned the board for inaction during prior hateful comments targeting LGBTQ students, criticized a recently passed resolution as harmful and ineffective, and urged specific board members to proactively protect transgender and gender-expansive students through inclusive policy and regulation.

Roux Whitmore –

- Condemned board members—particularly Michelle and Jeanette—for failing to protect transgender and queer students, accusing them of promoting hate, ignoring community voices, and enabling harassment, while vowing continued advocacy and warning of legal consequences.

Stephanie Maclean –

- Expressed deep frustration that despite repeated public opposition from community members, the board continues to pursue book and flag bans, accusing trustees of ignoring constituents in favor of outside influences and warning that community patience is wearing thin.

Emma Wolf –

- Criticized the board—especially Jeanette—for allowing public attacks on teachers and for undermining the profession by tolerating claims of indoctrination, emphasizing that educators aim to support and inspire students, not impose beliefs.

Christi Rettig –

- Opposed the proposed flag ban, calling it confusing and discriminatory, and urged the board—especially Michelle—not to let religious influence dictate public school policy, emphasizing the importance of separating church and



state in education.

Paul Hernandez –

- Expressed concern over perceived threats to freedom, opposing transgender athletes in women's sports and non-U.S. flags in schools, while criticizing what he called “communist Democrats” and urging greater appreciation for American values and service.

Lawrence Hebron –

- Criticized the disruptive behavior at the previous meeting—allegedly from one side of the debate—and urged President Rendler to take decisive action rather than pursue unlikely consensus, warning against policy gridlock.

Matt Applebee –

- Advocated for allowing Pride symbols in classrooms, citing evidence of academic and attendance benefits for LGBTQ students, emphasized that identities are not political, and warned that exclusionary policies risk legal and financial consequences under upcoming state requirements.

Katherine Applebee –

- Critiqued the proposed revisions to AR 1312.2, calling for clear definitions, fair and accountable review processes, mandatory full readings of challenged books by all decision-makers, equitable community participation, and public hearings held outside school hours to prioritize student involvement.

Sebastian Pstross –

- Opposed the flag and book ban policies, highlighting that flags promote student identity and inclusivity, warning of legal and financial risks, and emphasizing that book bans harm students who find safety and representation through reading.

Sara Cooper –

- Strongly condemned board members Olson and Wilson for promoting a “Save Girls Sports” agenda, accusing them of prioritizing personal beliefs over all students’ well-being, fostering family division, and contradicting the district’s stated commitment to diversity and inclusion.

Michael Cooper –

- Expressed disappointment in the board for diminishing student involvement and failing to properly vet teachers, sharing a personal grievance and harshly condemning the board’s actions as authoritarian.

Samantha Trad –

- Criticized the board for focusing on divisive culture war issues like flags, books, and trans athletes instead of student needs, condemned outside agitators imposing personal beliefs, and urged a return to prioritizing students’ safety, education, and respect.

Anita Rhodes –

- Praised the courage of trans youth, emphasized that their identities are openly expressed by their own choice, rejected claims that trans men seek unfair sports advantages, and encouraged resilience against opposition and personal

Rain Mendoza –

- Emphasized students' awareness of the world, affirmed that their identity does not affect their teaching, and called on the board to truly listen to

students' voices.
