
DESCRIPTION OF CHANGE:		
1. Re-route conduits and cold-water line 3 locations per RFI-007 response. Reason: To clear duct penetrations.		\$ 8,813.61
2. Install (6) roof curbs with counterflashing for the duct drops through the roof per DSA approved CCD-002. Reason: Meet the depth of the existing roof due to incorrect as-built drawings.		\$ 5,953.09
3. Infill for duct penetrations at window in Room N-103 per RFI-014 response. Reason: Size of duct is smaller than actual window we are replacing.		\$ 10,780.93
4. Add shaped 4x10 at RTU curbs per RFI-016 response. Reason: Detail 7/S8.1 stated "4x". Actual size required was a 4"x10" due to unforeseen (e) roof rigid insulation thickness.		\$ 2,686.44
5. Increase blocking size at each duct support frame location. Reason: Meet the depth of the existing roof due to incorrect as-built drawings.		\$ 4,903.62
6. Relocate thermostat for RTU #2 per RFI-013 response. Reason: In conflict with cooling system.		\$ 3,495.88
7. Access to structural framing thru ceiling per DSA approved CCD-002 and RFI-005 response. Reason: Meet the depth of the existing roof due to incorrect as-built drawings.		\$ 57,206.96
