3. Install the walkway lights ahead of the rest of the lights. Reason: Lights were needed to be expedited in this area.	\$ 3,687.00
4. Re-route and connect the irrigation wires. Reason: Conflicted with the new home bleacher foundation.	\$ 32,020.00
