

- a. **Certificated – Ratify/Adopt revised Resolution No. 39, 2024-2025, Action Regarding Teaching Outside Credential Authorization (Appendix Item).**

RESOLUTION NO. 39, 2024-2025

REDLANDS UNIFIED SCHOOL DISTRICT

ACTION REGARDING TEACHING OUTSIDE CREDENTIAL AUTHORIZATION

WHEREAS, the Redlands Unified School District has made a good faith effort to find qualified teachers; and

WHEREAS, Education Code Section 44256(b) allows, by resolution of the governing board, may authorize the holder of a multiple subject teaching credential or a standard elementary credential to teach any subject in departmentalized classes to a given class or group of students below grade 9, provided that the teacher has completed at least 12 semester units, or six upper division or graduate units, of coursework at an accredited institution in each subject to be taught. The authorization shall be with the teacher's consent.

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Redlands Unified School District that the following authorizations for assignments are hereby provided which shall be effective 2024-2025 and remain valid for one year:

WHEREAS, Education Code Section 44258.2 allows, by resolution of the governing board, may authorize the holder of a Single Subject or Standard Secondary Teaching Credential to be assigned to teach classes in grades 5 through 8 in a middle school. The teacher must have a minimum of twelve semester units or six upper division or graduate semester units of course work in the subject to be taught from an accredited institution. Action of the governing board and teacher consent is required.

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Redlands Unified School District that the following authorizations for assignments are hereby provided which shall be effective 2024-2025 and remain valid for one year:

WHEREAS, Education Code Section 44263 allows, by resolution of the governing board, may authorize the holder of a teaching credential teach any subject in departmentalized classes to a given class, provided that the teacher has completed at least 18 semester units, or nine upper division or graduate units, of coursework at an accredited institution in each subject to be taught. The authorization shall be with the teacher's consent.

Action by the local governing board is required.
